## RULES & REGULATIONS

1. Entries close the Wednesday prior to the show at 9:00 P.M. Post entries will not be accepted. Please pre enter! No scratch fees will apply. Although pre payments are not accepted, any entry fees in the event of cancellation will be refunded by original payment method.
2. Day stalls available upon reservation for \$75.00 per day for the show. #1 entries close the Thursday prior to the show at 9:00am post entries will be accepted with a \$50 post entry fee.
3. There will be a \$150.00 charge for horses/ponies using the show amenities but not showing.
4. All horses/ponies must school with a back number.
5. Baymar Farms, Inc., Jim & Ellie Smith, or anyone on the show committee will not be responsible for any accident, loss or damage at the show.
6. Committee reserve the right to cancel/combine move or substitute classes at their discretion.
7. Schooling will be permitted only in areas provided by the committee and scheduled as time permits.
8. Hunter jumper courses may include gates, walls, bushes, oxers, panels and combinations.
9. Indoor ring is 175X300, 140X275 with sand / stonedust footing.  
All warm up areas are sand and fibar footing or stonedust.
10. Hunters will be judged on performance, soundness, and manners. Trophy and 8 ribbons for each section.
11. Every class offered is run in accordance with the specs of the current USEF rules.
12. A jump order will be established at the gate with the starter.
13. All ties, other than first place, will be broken by time.
14. All pets must be kept on a leash.
15. Sharps containers will be located at the show office.
16. All entries not paid at the horse show will incur a \$ 50.00 late payment fee.
17. A \$50.00 fee will be charged to all entries for office fee to cover emt and grounds fees.
18. For all sanctioned classes other than USEF pointed classes such as NAL/WIHS/THIS/Ariat/M&S, horse and rider combination must enter at least one other class at that same show.
19. All prize money will be issued at the show.
20. Anyone mounted on the show grounds.
21. HEADGEAR RULE UPDATE: SHOW WILL RUN IN ACCORDANCE WITH CURRENT RULES UNDER.
22. No refunds on prize \$ classes once the order of go has been posted or the division has started.
23. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violators of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of a personal electronic transport device, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to Segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed 'unsafe use' if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of the minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
24. Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USHJA as published in the USHJA Rule Book and on the website at [www.USHJA.org](http://www.USHJA.org), as amended from time to time.

B.
